ACCOUNTABILITY REQUIREMENTS

The School Board hereby certifies that the projects included in this bond that voters and taxpayers in the District may be assured that their money will be spent wisely and responsibly to address the technology equipment needs of the District will be in compliance with the requirements of Article XIII, Section 1(b)(3), of the State Constitution and the Strict Accountability in Local School Construction Bonds Act of 2000 (codified at Education Code Sections 15264 and following).

Evaluation of Needs. The School Board has identified detailed technology equipment needs of the District and has determined which projects to finance from a local bond at this time. The School Board hereby certifies that it has evaluated safety, class size reduction, enrollment growth, and information technology needs in developing the Bond Project List shown below.

Independent Citizens' Oversight Committee. The School Board has an established Independent Citizens' Oversight Committee under Education Code Section 15278 and will meet frequently enough to ensure that bond proceeds are expended only on the bond projects listed below.

Performance Audits. The School Board shall conduct an annual performance audit to ensure that the bond proceeds have been expended only on the school technology equipment projects listed below. After the first bond sale and prior to the second bond sale, the established Technology Committee composed of representatives from the Board of Trustees and other key stakeholders shall monitor technology program implementation and recommend potential revisions.

Financial Audits. The School Board shall conduct an annual independent financial audit of the bond proceeds and of those proceeds that have been spent for the school technology equipment projects listed below.

FURTHER SPECIFICATIONS

The Technology Equipment Construction Bond proceeds may not be expended for school operating expenses, including administrator and teacher salaries, which are not attributable to technology projects.

BOND PROJECT LIST

Scope of Projects. Bond proceeds will be expended to modernize, replace, renovate, acquire, install, equip, maintain, and otherwise improve educational technology equipment projects and supporting systems and software within the District. Projects which are described below include all related and incidental costs, including their share of the costs of the election and bond sale, engineering, architectural, and other professional services, post-construction site preparation, utilities, and other planning, legal, accounting, and similar costs, independent annual financial and performance audits, a customary contingency, and other costs incidental to and necessary for completion of the listed projects.

Bond proceeds may also be expended to acquire equipment in an individual classroom or other

Whenever specific items are included in the following list, they are intended to provide examples and are not intended to limit the generality of the broader description

of authorized projects. The order in which particular projects are listed will not indicate any priority or ranking.

Specific educational technology projects and related activities are not limited to:

Devices and Technology Systems

- Computers and peripherals
- Laptops, eReaders, eTablets, Chromebooks, Netbooks, "Bring Your Own Device" computing devices
- Projectors/Projection TV monitors
- Data backup systems
- Mobile computing devices including any cars/tablets
- Wireless access devices and networks

Software

- Computer adaptive software/learning management systems
- Application (App)/management software for mobile devices

Infrastructure

- Core, router and technology testing, network (SAN) and other information devices

Implementation

- Installation and upgrading of various technology
- Training and related expenses resulting from the implementation of technology

Projects Subject to Available Funding. The foregoing list of projects is subject to the availability of state funds. It is not guaranteed that the proposed projects in the measure will be funded beyond the revenues generated by the bond measure. The District's proposal for the projects may assume the receipt of existing state funds, which could be subject to appropriation by the Legislature under a statewide bond measure.
